You should start your M.A. Degree Program as soon as possible so that enrollment is concurrent with your D/MT Alternate Route Training. 5 Years Intensive Dance Training is required along with specific course work for DTR Registry. Alternate route candidates should notify the American Dance Therapy Association that they have started their alternate route training.
